

**GPS MONTHLY/WEEKLY RENTAL AGREEMENT**

Upon sending this agreement by fax, email, or US Mail to [www.gpsrentalnow.com](http://www.gpsrentalnow.com), I will be charged **(select amount)** \$350.00 \_\_\_\_\_ per week or \$1000.00 \_\_\_\_\_ per month rental fee for my **(select device)** \_\_\_\_\_ GPS device Number (1) or \_\_\_\_\_ GPS device number (2), and a one-time 100% refundable deposit of \$600.00 for a total of \$950.00 for the weekly plan or \$1600 for the monthly plan.

If I do not accept delivery, I will be charged the amount equivalent to my payment selection of one week or one month to cover processing, shipping, and inventory expenses.
